The May Branch project is located in Fort Smith, Arkansas. It will be executed by the Little Rock District Corps of Engineers. The local sponsor is the City of Fort Smith.

The purpose of the congressionally directed spending item:

The May Branch project is intended to reduce flood damage in Fort Smith, Arkansas. May Branch flows through a covered conduit within the city limits into the Arkansas River. Flooding causes an estimated \$1.7 million in annual damages. This project would consist of channels, road and railroad crossings, and a gated structure through the levee.

The Augusta and Clarendon, Arkansas project is located in White and Prairie Counties, Arkansas.

It will be executed by the Memphis District of the Corps of Engineers. The White River Levee

District is the local sponsor for the project.

The purpose of the congressionally directed spending item:

The project is located in Arkansas along the White River in White and Prairie Counties. The authorized plan provides for a levee along the east bank of the White River and around the town of Georgetown on the west bank with structures to care for interrupted drainage. The work consists of 47 miles of levee and the necessary drainage structures. Approximately 39 miles of the authorized levee work is complete. This request further modifies the authority of the Secretary to rehabilitate the completed portion of the levee from Augusta to Clarendon.

The Des Arc Levee Protection project is located in Prairie County, Arkansas. It will be executed by the Memphis District of the Corps of Engineers.

The purpose of the congressionally directed spending item:

This project provides for protection of Des Arc, Arkansas, from White River floodwaters. The authorized features of the project include an earthen levee, a sewage pump, a storm water pump, two 60-inch culverts with floodgates and a sump area of 92 acre-feet. Bank caving and scour created by the White River is nearing the levee. This request authorizes the Secretary to review the Des Arc Levee to determine if bank and channel scour along the White River threaten the existing authorized features of the project. If a deficiency is found, the Secretary should construct, operate, maintain, replace, or rehabilitate these measures to eliminate the deficiencies.




For the congressionally directed spending item, the name and location of the intended recipient or, if there is no specifically intended recipient, the intended location of the activity:

The Pine Mountain Dam project is located in Crawford County, Arkansas. It will be executed by the Little Rock District of the Corps of Engineers. The River Valley Regional Water District is the local sponsor of the project.

The purpose of the congressionally directed spending item:

The Pine Mountain Dam project was authorized in the Flood Control Act of 1965 to construct a dam on Lee Creek. The project would create a lake for flood control, water supply, recreation, and fish and wildlife enhancement. This modification to the authorization would add environmental restoration as a project purpose and direct the Secretary to finance the non-Federal share of the cost of the project over a 30-year period in accordance with section 103(k) of the Water Resources Development Act of 1986 (33 U.S.C. 2213(k)).




For the congressionally directed spending item, the name and location of the intended recipient or, if there is no specifically intended recipient, the intended location of the activity:

The St. Francis Basin, Arkansas and Missouri, project is located in northeast Arkansas and southeast Missouri. It will be executed by the Memphis District of the Corps of Engineers. The local sponsor of this project is the Arkansas Game and Fish Commission.

The purpose of the congressionally directed spending item:

The Arkansas Game and Fish Commission currently manages mitigation lands located in the St. Francis Basin project. The Corps of Engineers, the Game and Fish Commission, and the U.S. Fish and Wildlife Service see a tremendous benefit in the fee title transfer of these mitigation lands to the Game and Fish Commission directly from the Corps of Engineers. These lands would be an excellent compliment to the St. Francis Sunken Lands Wildlife Management Area administered by the state of Arkansas. This request authorizes and sets the terms and conditions for the Secretary to transfer the land to the Game and Fish Commission.

The Cache River Basin, Grubbs, Arkansas project is located in Jackson County, Arkansas. It will be executed by the Memphis District of the Corps of Engineers.

The purpose of the congressionally directed spending item:

The Cache River Basin feasibility study will assess flood control measures. Each year, thousands of acres are flooded due to large masses of timber, silt, garbage and other debris that block the flow of the Cache River. Heavy flooding is concentrated in an area on the Cache River south of Grubbs, Arkansas. However, the flooding is not limited to this area and has detrimentally affected areas in Poinsett and Craighead counties, as well. Study would provide estimates on the scope and extent of work needed to provide channel restoration and flood damage reduction and allow the Secretary to proceed with the project.

The White River Basin comprises approximately 28,000 square miles in northeastern Arkansas and southern Missouri. The potential project outputs include optimization of reservoir operations, and comprehensive projects to address water resource needs for water supply, flood control, waste water management, navigation, recreation, power generation, and other water resources-related needs identified in the comprehensive study. This authorization will modify the non-federal cost share agreement and require a non-federal match of 25 percent.




For the congressionally directed spending item, the name and location of the recipient or, if there is no specifically intended recipient, the intended location of the activity:

The Little Red River Irrigation District is located in White County, Arkansas. The project will be executed by the Little Rock District of the Corps of Engineers.

The purpose of the congressionally directed spending item:

This project includes southern and eastern areas of White County, Arkansas. The Little Red River Irrigation District wishes to reverse the declining trend of the water table, the Alluvial Aquifer, by developing a reliable surface water irrigation source for approximately 81,000 acres, including 35,000 acres of irrigated cropland. This request authorizes the Secretary to expedite the feasibility report and environmental assessment for the rural water supply project for the Little Red River and include modifications for water supply and environmental restoration.
